As Nebraska Cures began 2025, we faced one of the most challenging environments for medical research and public health in recent memory. Attacks on research funding reinforced the importance of our mission and the need for strong advocacy at both the state and national levels.

Throughout the year, Nebraska Cures remained committed to supporting research, innovation, and evidence-based policy. We continued our behavioral health coalition work, advancing conversations around mental health policy and preparing for the release of the coalition's statewide study. We also continued to expand Nebraska Women in STEM through the launch of a State Capitol Day our largest ever Nebraska Women in STEM Conference.

This report highlights these efforts and more. While 2025 brought significant challenges, it also underscored the importance of collaboration, advocacy, and investing in Nebraska's future.

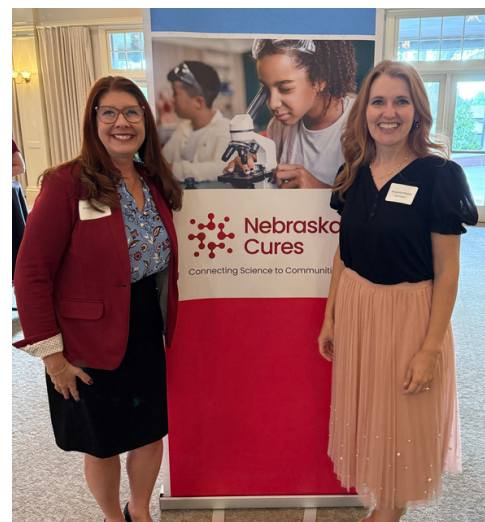
Our Mission: Nebraska Cures promotes, supports and advocates for scientific research and education to advance our quality of life and our economy.

RESEARCH EDUCATION

Nebraska Cures brought together researchers from the University of Nebraska System, Creighton University, and Boys Town National Research Hospital to meet with policymakers on the federal and state levels to educate them on the importance of investing in biomedical research. During the 2025 legislative session, Nebraska Cures Executive Director Amanda McGill Johnson and board member Dr. Julie Strauss Sokoup testified against cuts before the Appropriations Committee.

Nebraska Cures also partnered with Bio Nebraska launch an advocacy training for Nebraska Women in STEM. Eighteen women came to the Capitol to meet with senators and discuss the importance of supporting the STEM workforce.

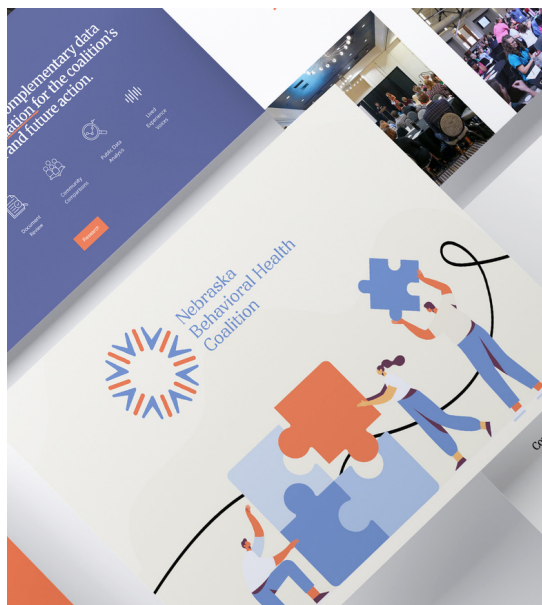
NEBRASKA CURES IS A MAJOR STAKEHOLDER IN

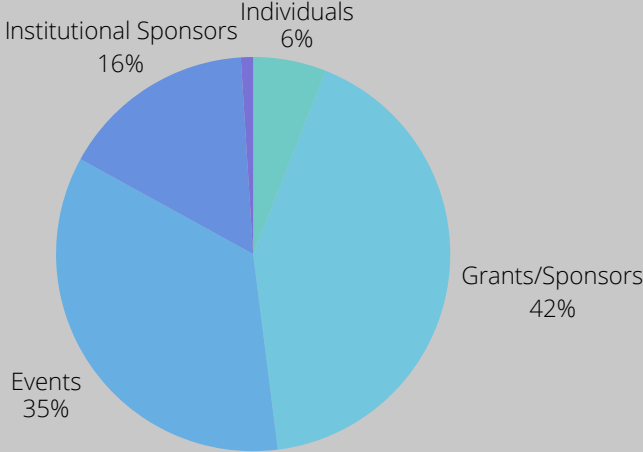
